Although the oil industry rebounded in 2021, activity in the rest of the economy was slow to recover from the pandemic amid employment and earnings losses. This was reflected in the performance of alcoholic drinks, with a further drop in volume sales in both on- and off-trade channels, through the drop in volume sales was more severe through retail channels. However, with the pandemic still lingering, footfall in the on-trade channel was well below pre COVID-19 levels.
