Guatemala has recovered strongly after the disruptions caused by the 2020 COVID-19 restrictions, with volume sales in 2021 being higher than before the onset of COVID-19. Foodservice channels registered double-digit volume growth and retail channels also registered positive growth. Population growth also supported volume sales. All the same, there was increasing price sensitivity due to relatively high inflation and this resulted in a degree of trading down to cheaper brands.
