RTDs witnessed a significant improvement in on-trade sales in 2021 as social distancing measures gradually relaxed during the year, leading to increasing numbers of local consumers returning to bars and pubs (which were permitted to resume normal operations later in the year), due to pent-up demand. Nevertheless, on-trade volume sales remained significantly lower than pre-pandemic levels in 2021, as bars were not able to operate at normal levels in the first half of the year, thus hampering a st...
