Spirits registered a decline in volume sales for the second year running, mainly due to supply issues of Costa Rica's most popular spirit, guaro (see below). However, premium spirits performed well in 2021, with Tequila (and mezcal) being the strongest performers. With many consumers still drinking spirits at home rather than in bars, as the pandemic lingered, there was increased interest for premium spirits, as they are more affordable through retail channels.
