Spirits are largely dependent on on-trade channels, with more than half of volume sales normally sold through foodservice channels. As a result, spirits were hugely negatively impacted by the 2020 COVID-19 restrictions. In 2021, with society opening, spirits registered double-digit volume growth, with volume sales being slightly higher than before the onset of COVID-19.
