The average unit price of takju increased in the aftermath of tax hikes and inflation. In April 2021, leading player Seoul Takju Association raised the price of Jangsu Makkeoli by KRW120, resulting in the retail price at convenience stores reaching KRW1,600. In July, premium takju player Bae Brewing Co increased the price of Slow Village Makgeolli by 17.2% from KRW2,900 to KRW3,400, and another takju player, Kooksoondang Brewery Co Ltd, increased the price of its Saeng Makkeoli by 25%.
