In addition, the growing research and development activities by the leading vacuum truck providers to develop simplified designs with high power and excellent payload capacity are anticipated to provide impetus to the market in the coming years. In terms of region, the Asia Pacific accounts for a significant share of the market owing to increasing infrastructure development activities across emerging economies such as India and China. Furthermore, the stringent government regulations pertaining to environmental protection and conservation of natural resources, such as the green norms introduced by the National Green Tribunal (NGT) of India, are likely to accelerate the market growth in the forecast period.
