Cider/perry turned to decline in total volume terms in 2020 during the pandemic, as on-trade outlets closed, and sales plummeted in this channel. Although off-trade sales saw some growth, it was insufficient to offset the on-trade decline. A rebalancing of sales was seen in 2021, with on-trade sales rebounding to almost the pre-pandemic level, with the off-trade seeing a resultant decline. Cider/perry is slated to maintain total volume growth in the early forecast period, reversing the negative...
