RTDs have long been popular in Finland, with the leading brand, Hartwall Original Long Drink, launched for the 1952 Summer Olympics in Helsinki. RTDs have also benefitted from the 2018 change in regulation, which permits RTDs of up to 5.5% ABV, rather than the previous 4.7%, to be sold through grocery outlets, rather having to visit Alko outlets (state-run alcoholic drinks specialist retailers)...
