The wine category recorded a high single-digit total volume decline in 2021. While some alcoholic drinks categories, such as RTDs, saw volumes return to the pre-pandemic level, or like beer and cider/perry, saw significantly higher growth than in 2020, wine suffered from continued volume decline, although this was slower compared with the previous year. In 2021, rice wine accounted for more than 60% of total volume sales of wine and saw an overall low single-digit decline. The decline for rice w...
