Total volume sales of RTDs slumped by almost a fifth during 2020 and recovered only partially in 2021. Unsurprisingly, on-trade demand bore the brunt of this, with on-trade volume sales plunging by almost a third during 2020. On-trade demand is more significant for RTDs than most other types of alcoholic drinks in Romania, with spirit-based RTDs dominant. These products are particularly appealing to younger consumers. However, they face strong competition from home-made mixes of spirits like vod...
