The China cardiovascular ultrasound market is expected to register a CAGR of 6.03% during the forecast period, 2022-2028. The high cardiovascular mortality rate is one of the primary growth drivers of the cardiovascular ultrasound market in China.

Furthermore, the cardiovascular mortality rate was 364.5 per 100,000 population in 2019. In addition, cardiovascular disease accounted for 2 out of 5 deaths. Also, new companies, like Dawei Medical and Shenzhen Lanmage, are entering the market with innovative systems. Such factors boost the market growth in China.
