Alcoholic drinks registered positive growth in 2021 as sales rebounded from the severe declines recorded at the peak of the COVID-19 pandemic in 2020. In particular, on-trade sales slumped in 2020 due to the absence of foreign tourists and an extended hospitality sector shutdown, while off-trade sales came under pressure due to a month-long alcohol sales ban. In addition, tax increases and high inflation have pushed many consumers into the illicit trade, which has mainly hit sales of spirits.
