The market value is the total turnover of agencies from the provision of these services. Services such as employee leasing and independent contracting are not included.
- The US employment services market had total revenues of \$136.4 billion in 2021, representing a compound annual growth rate (CAGR) of 1.5% between 2016 and 2021.
- Market consumption volumes declined with a CAGR of -2.1% between 2016 and 2021, to reach a total of 2.9 million temporary agency employees in 2021.
- The US market accounts for 30.7% of the global market.
