- The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$116.7bn, equivalent to 62.2% of the industry's overall value.
- Decline of 7.7% in 2020 can be attributed to the COVID-19 pandemic which greatly impacted the Russian construction market as supply chain disruptions delayed construction projects and inhibited growth in the market.
