- The Physical segment was the market's most lucrative in 2021, with total revenues of \$2.9bn, equivalent to 78.7% of the market's overall value.
- The lockdown measures that were enforced in response to the coronavirus pandemic forced the closure of various physical bookstores leading to an impact on the Italian books market. However, the ease in restrictions and the increase in vaccinations drove the growth of the market in 2021.
