- The Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$152.5bn, equivalent to 60.1% of the industry's overall value.
- Decline in 2020 can be attributed to the COVID-19 pandemic which greatly impacted the Italian construction market as supply chain disruptions delayed construction projects and inhibited growth in the market.
