- The Italian real estate industry had total revenues of \$75.9bn in 2021, representing a compound annual growth rate (CAGR) of 1.5% between 2016 and 2021.
- Industry consumption volumes declined with a compound annual rate of change (CARC) of -0.1% between 2016 and 2021, to reach a total of 7.1 thousand units in 2021.
- The value of the Italian real estate industry declined by 0.4% in 2021.
