- The Norwegian Construction industry had total revenues of \$79.1bn in 2021, representing a compound annual growth rate (CAGR) of 4.4% between 2016 and 2021.
- The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$45.8bn, equivalent to 57.9% of the industry's overall value.
- Decline in 2020 can be attributed to the COVID-19 pandemic which greatly impacted the Norwegian construction market as supply chain disruptions delayed construction projects and inhibited growth in the market.
