- The Spanish Construction industry had total revenues of \$179.1bn in 2021, representing a compound annual growth rate (CAGR) of 5% between 2016 and 2021.
- The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$89.6bn, equivalent to 50% of the industry's overall value.
- Decline in 2020 of 6% was likely due to economic disruption induced by the COVID-19 pandemic. This significantly hampered economic activity and resulted in the cancellation and delays of many construction projects.
