- The Swedish Construction industry had total revenues of \$89.3bn in 2021, representing a compound annual growth rate (CAGR) of 6.8% between 2016 and 2021.
- The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$46.4bn, equivalent to 52% of the industry's overall value.
- Depressed growth of 4.2% in 2020 can be attributed to the COVID-19 pandemic which greatly impacted the Sweden construction market as supply chain disruptions delayed construction projects and inhibited growth in the market.
