- The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$154.5bn, equivalent to 69.1% of the industry's overall value.
- Decline in 2020 of 28.2% was likely due to economic disruption induced by the COVID-19 pandemic. This significantly hampered economic activity and resulted in the cancellation and delays of many construction projects.
