- The commodity chemicals segment accounted for the largest proportion of the market in 2021, with total revenues of \$14.0 billion, equivalent to 47% of the market's overall value.
- The production of chemicals is the second largest manufacturing segment in Singapore, after electronics. Singapore has strong upstream and downstream links in the market and most chemical companies are conveniently located on a manmade island called Jurong Island.
