- Among the G8 nations, the US is the leading country in the air freight industry, with market revenues of \$17,103.2 million in 2021. This was followed by Japan and Germany, with a value of \$6,547.2 and \$5,451.0 million, respectively.
- The US is expected to lead the air freight industry in the G8 nations with a value of \$21,081.7 million in 2016, followed by Japan and Germany with expected values of \$8,860.9 and \$7,392.9 million, respectively.
