- Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the air freight industry and had a total market value of \$21,949.5 million in 2021. Russia was the fastest growing country with a CAGR of 4.2% over the 2017-21 period.
- Within the air freight industry, China is the leading country among the BRIC nations with market revenues of \$16,093.6 million in 2021. This was followed by Russia, India and Brazil with a value of \$4,132.8, \$1,054.3, and \$668.8 million, respectively.
- China is expected to lead the air freight industry in the BRIC nations with a value of \$22,076.1 million in 2026, followed by Russia, India, Brazil with expected values of \$6,495.1, \$1,346.2 and \$909.3 million, respectively.
