- Within the medium & heavy trucks industry, China is the leading country among the BRIC nations with market revenues of \$132.3 billion in 2021. This was followed by India, Russia and Brazil with a value of \$11.2, \$0.9, and \$0.6 billion, respectively.
- China is expected to lead the medium & heavy trucks industry in the BRIC nations with a value of \$183.7 billion in 2026, followed by India, Brazil, Russia with expected values of \$16.1, \$0.8 and \$0.7 billion, respectively.
