- Within the real estate industry, China is the leading country among the top 5 emerging nations, with market revenues of \$1,713.5 billion in 2021. This was followed by India and Mexico with a value of \$126.4 and \$50.1 billion, respectively.
- China is expected to lead the real estate industry in the top five emerging nations, with a value of \$1,739.1 billion in 2026, followed by India and Mexico with expected values of \$152.0 and \$76.0 billion, respectively.
