- Within the government spendings industry, China is the leading country among the BRIC nations with market revenues of \$3,818.0 billion in 2021. This was followed by Brazil, India and Russia with a value of \$803.3, \$554.0, and \$329.0 billion, respectively.
- China is expected to lead the government spendings industry in the BRIC nations with a value of \$4,924.7 billion in 2026, followed by Brazil, India, Russia with expected values of \$1,036.5, \$785.6 and \$551.9 billion, respectively.
