- Within the government spendings industry, China is the leading country among the top 5 emerging nations, with market revenues of \$3,818.0 billion in 2021. This was followed by Brazil and India with a value of \$803.3 and \$554.0 billion, respectively.
- China is expected to lead the government spendings industry in the top five emerging nations, with a value of \$4,924.7 billion in 2026, followed by Brazil and India with expected values of \$1,036.5 and \$785.6 billion, respectively.
