- Within the construction industry, China is the leading country among the top 5 emerging nations, with market revenues of \$4,544,587.3 million in 2021. This was followed by India and Mexico with a value of \$589,176.4 and \$149,353.8 million, respectively.
- China is expected to lead the construction industry in the top five emerging nations, with a value of \$6,516,627.7 million in 2026, followed by India and Mexico with expected values of \$848,517.5 and \$206,849.5 million, respectively.
