- Within the dog care industry, China is the leading country among the BRIC nations with market revenues of \$3,985.8 million in 2021. This was followed by Brazil, Russia and India with a value of \$2,922.6, \$425.3, and \$375.0 million, respectively.
- China is expected to lead the dog care industry in the BRIC nations with a value of \$13,834.6 million in 2026, followed by Brazil, India, Russia with expected values of \$3,559.2, \$690.9 and \$687.1 million, respectively.
