- Within the pet healthcare industry, the US is the leading country among the NAFTA bloc, with market revenues of \$11,531.3 million in 2021. This was followed by Canada and Mexico, with a value of \$521.8 and \$257.5 million, respectively.
- The US is expected to lead the pet healthcare industry in the NAFTA bloc, with a value of \$13,960.6 million in 2026, followed by Canada and Mexico with expected values of \$615.6 and \$330.8 million, respectively.
