- Within the pet healthcare industry, Brazil is the leading country among the top 5 emerging nations, with market revenues of \$360.6 million in 2021. This was followed by Mexico and China with a value of \$257.5 and \$249.2 million, respectively.
- Brazil is expected to lead the pet healthcare industry in the top five emerging nations, with a value of \$438.7 million in 2026, followed by Mexico and China with expected values of \$330.8 and \$300.2 million, respectively.
