The diapers segment consists of baby, cloth and training diapers. The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2021 exchange rates.
- The global baby personal care market had total revenues of \$47,063.9m in 2021, representing a compound annual growth rate (CAGR) of 7.5% between 2016 and 2021.
- Market consumption volumes declined with a CAGR of 0% between 2016 and 2021, to reach a total of 4,012.8 million units in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 8.6% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$71,088.1m by the end of 2026.
