The global synthetic diamonds market is forecasted to register a CAGR of 8.89% in terms of revenue during the estimated years 2022 to 2030. The prices of synthetic diamonds are expected to drop further as the supply chain is relatively shorter and the process is renewable. Furthermore, the manufacturing of synthetic diamonds is on the rise as production becomes faster and less expensive. Since the affordability and manufacturing of synthetic diamonds are surging, the aforementioned factors are expected to be key drivers fueling the global synthetic diamond market growth.
