All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The Indian Breakfast Cereals market had total revenues of \$630.6m in 2021, representing a compound annual growth rate (CAGR) of 22.1% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 14.3% between 2016 and 2021, to reach a total of 112.4 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 12.3% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$1,124.4m by the end of 2026.
