- Market consumption volume increased with a CAGR of 6.8% between 2016 and 2021, to reach a total of 6.8 billion kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 6.8% for the five-year period 2021 2026, which is expected to drive the market to a value of \$12,727.5m by the end of 2026.
