- The breakfast cereals market consists of retail sales of hot cereals and ready-to-eat cereals. Hot cereals segment consists of traditional products (e.g. porridge oats), instant mixes and ready-to-heat products. Ready-to-eat cereals segment consists of children's breakfast cereals and family breakfast cereals such as, flakes, muesli and other RTE cereals. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The Indonesian Breakfast Cereals market had total revenues of \$101.4m in 2021, representing a compound annual growth rate (CAGR) of 9.5% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 4.7% between 2016 and 2021, to reach a total of 13.1 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 5.9% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$135.3m by the end of 2026.
