- The French bakery & cereals market had total revenues of \$29,433.1m in 2021, representing a compound annual growth rate (CAGR) of 2.1% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1.1% between 2016 and 2021, to reach a total of 5.7 billion kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.5% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$33,360.7m by the end of 2026.
