- Sector production volumes declined with a CAGR of -5.2% between 2016 and 2021, to reach a total of 3.2 billion freight ton-kilometers (FTK) in 2021.
- The sector recorded steep decline in 2020 of 45.4% largely due to the COVID-19 pandemic. The leading players in the region were forced to follow government restrictions in order to curtail the spread of the virus.
