The market is valued according to retail selling price (RSP) and includes any applicable taxes. - The Turkish bakery & cereals market had total revenues of \$7,231.3m in 2021, representing a compound annual growth rate (CAGR) of 15.3% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 0.9% between 2016 and 2021, to reach a total of 13 billion kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 21.4% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$19,093.8m by the end of 2026.
