Pizza includes both frozen and chilled pizza. Meal kits are products which provide prepared ingredients which are then combined to an individual's preference when being cooked. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The Turkish Prepared Meals market had total revenues of \$34.4m in 2021, representing a compound annual growth rate (CAGR) of 14.5% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 2.6% between 2016 and 2021, to reach a total of 13.3 million kg in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 18.5% for the five-year period 2021 2026, which is expected to drive the market to a value of \$80.2m by the end of 2026.
