- Market consumption volume increased with a CAGR of 2% between 2016 and 2021, to reach a total of 160.2 billion kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.2% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$791,404.8m by the end of 2026.
