All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The global Prepared Meals market had total revenues of \$102,718.7m in 2021, representing a compound annual growth rate (CAGR) of 4.4% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 3.2% between 2016 and 2021, to reach a total of 12,478.6 million kg in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.8% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$123,820.7m by the end of 2026.
