- Within the construction materials industry, China is the leading country among the top 5 emerging nations, with market revenues of \$654,608.6 million in 2021. This was followed by India and Mexico with a value of \$85,929.1 and \$11,677.6 million, respectively.
- China is expected to lead the construction materials industry in the top five emerging nations, with a value of \$933,928.9 million in 2026, followed by India and Mexico with expected values of \$135,689.2 and \$15,641.9 million, respectively.
