- Within the prepared meals industry, the US is the leading country among the NAFTA bloc, with market revenues of \$23,802.1 million in 2021. This was followed by Canada and Mexico, with a value of \$4,289.4 and \$428.5 million, respectively.
- The US is expected to lead the prepared meals industry in the NAFTA bloc, with a value of \$29,042.8 million in 2026, followed by Canada and Mexico with expected values of \$5,078.7 and \$547.0 million, respectively.
