The Mexico was the fastest growing country, with a CAGR of 4.4% over the 2017-21 period.
- Within the bakery & cereals industry, the US is the leading country among the NAFTA bloc, with market revenues of \$128,236.4 million in 2021. This was followed by Mexico and Canada, with a value of \$21,281.9 and \$12,247.6 million, respectively.
- The US is expected to lead the bakery & cereals industry in the NAFTA bloc, with a value of \$151,597.1 million in 2026, followed by Mexico and Canada with expected values of \$26,074.8 and \$15,168.5 million, respectively.
