- Within the soups industry, the US is the leading country among the NAFTA bloc, with market revenues of \$7,486.2 million in 2021. This was followed by Canada and Mexico, with a value of \$771.9 and \$188.0 million, respectively.
- The US is expected to lead the soups industry in the NAFTA bloc, with a value of \$9,353.7 million in 2026, followed by Canada and Mexico with expected values of \$985.1 and \$254.0 million, respectively.
