- Within the soups industry, Brazil is the leading country among the top 5 emerging nations, with market revenues of \$294.9 million in 2021. This was followed by Mexico and India with a value of \$188.0 and \$118.1 million, respectively.
- Brazil is expected to lead the soups industry in the top five emerging nations, with a value of \$408.6 million in 2026, followed by Mexico and India with expected values of \$254.0 and \$174.9 million, respectively.
