The breakfast cereals industry within the NAFTA countries had a total market value of \$15,493.9 million in 2021. The Mexico was the fastest growing country, with a CAGR of 5.6% over the 2017-21 period.
- Within the breakfast cereals industry, the US is the leading country among the NAFTA bloc, with market revenues of \$11,659.1 million in 2021. This was followed by Mexico and Canada, with a value of \$2,307.2 and \$1,527.7 million, respectively.
- The US is expected to lead the breakfast cereals industry in the NAFTA bloc, with a value of \$13,003.2 million in 2026, followed by Mexico and Canada with expected values of \$3,048.7 and \$1,704.4 million, respectively.
